Tax Free Childcare

Tax Free Childcare is a Government scheme to help working parents with the cost of childcare.

Your Tax Free Childcare account gives you access to an online account which can then be used to send payments directly to Hampshire County Council's bank account via BACS.

HOW TO USE TAX-FREE CHILDCARE

For every £8 you pay in, the government will automatically add £2, up to the value of £2,000 per child per year (or £4,000 for disabled children)

PAY MONEY INTO YOUR CHILDCARE ACCOUNT

You can deposit money into your
childcare account using a debit card,
but it's quicker by standing order or
bank transfer. We'll add the
government top up automatically
and you can use this money when it
shows as 'available'.

Your childcare provider(s)
must sign up to receive Tax-Free
Childcare payments.

account, including the government
